NOTICE OF WAIVED PUBLIC HEARING

Notice is hereby given that, pursuant to Section 464(2) of the *Local Government Act*, the District of Tofino is waiving the requirement for a public hearing for an amendment to “District of Tofino Zoning Bylaw No. 1288, 2020” which increases access and opportunities for high quality, affordable childcare in Tofino. The proposed amendments include:

- *Adding the following definitions:*
 - *COMMERCIAL CHILD CARE means Group Child Care, Preschool, Occasional Child Care, and Multi-Age Child Care programs that are licensed under the Child Care Licensing Regulation.*
 - *RESIDENTIAL CHILD CARE means Family Child Care and In-Home Multi-Age Child Care programs that are licensed under the Child Care Licensing Regulation.*
- *Updating the Home Occupations section to reflect the new definitions.*
- *Adding commercial childcare as a permitted use to the following zones.*
 - C1, C2, C2-A C3, C-4A, C5, C6, C7, CD(1431), CD(EL), CD-GP, CD(TS), CD-DC1, CD-DC3, CD-DC4, CD-DC5, CD-DC6, P1, and P1-A.

BYLAW: “District of Tofino Zoning Amendment Bylaw No.1288, 2020”, amending Zoning Bylaw No. 770.

LANDS: The proposed amendment would impact residential zones where child care is a permitted use, as well as the following zones: C1, C2, C2-A C3, C-4A, C5, C6, C7, CD(1431), CD(EL), CD-GP, CD(TS), CD-DC1, CD-DC3, CD-DC4, CD-DC5, CD-DC6, P1, and P1-A.

APPLICANT: District of Tofino.
